Subject:- Recommendation No. 69 : DsGP/IsGP Conference 2015.

Sir/Madam,

Issue of empowering and associating women in law enforcement has been discussed at various forums in the past. To take concrete action in this regard a committee was formed with DG, BPR&D as Chairperson with DsGP of different states as its member to suggest implementable innovative ideas for different States/UTs. (Kindly refer recommendation at para 69 regarding empowerment of women through police activities, as stated in the DsGP and IsGP conference 2015)

After elaborate discussions with different stakeholders, the committee recommends the following initiatives for implementations by respective States/UTs.

1. Mahila Police Volunteer Scheme, developed by Ministry of Women and Child Development, GOI (Annex-1)
2. Uttar Pradesh Police initiatives - SAATHI, AKSHAYA, VIKALP and RU-BA-RU (Annex-II)
3. Delhi police initiative of empowering women through Self Defense (Annex-III)
4. Gir forest initiatives of empowerment of women through their association in beat patrolling (Annex-VI)
