**ORDER**

Sub: Police Dept., - Estt.- I(B) - Recruitment to the post of Police Constable - Thiru. K.Vijendiran, (Roll No.2736) - Cancellation of provisional selection - Order - Issued - Reg.

WHEREAS, Thiru. K.Vijendiran, (Roll No.2736) was instructed to appear for original certificate verification on or before 12.09.2022 vide Memorandum 2<sup>nd</sup> cited consequent to the provisional selection in the wait list of the written examination held on 19.03.2022 notified vide Notification 1<sup>st</sup> cited.

WHEREAS, Thiru. K.Vijendiran, (Roll No.2736) has failed to appear for original certificate verification in spite of being granted time till 12.09.2022.

WHEREAS, Thiru K.Vijendiran was granted sufficient opportunity and inspite of Notices issued, he has not turned up for Certificate verification. In the meantime, he has filed a Writ Petition in W.P.No.25471 of 2022 with a prayer to direct the 2<sup>nd</sup> Respondent in the Writ Petition (Tahsildar, Taluk Office, Oulgaret) to issue nativity and caste certificate to the petitioner. In the said Writ Petition, the Hon'ble High Court of Judicature at Madras, has passed an order dated 22.09.2022 with a direction to the 3<sup>rd</sup> Respondent Deputy Collector (Revenue) North, Puducherry to consider the pending appeal within a period of three weeks from the date of receipt of the copy of the order and till then the provisional selection shall not be cancelled and one post under the MBC quota shall be kept vacant and disposed of the Writ Petition.

WHEREAS, The Deputy Collector (Revenue) North, Puducherry, has issued an order No.6497/DCRN/A2/CERT/2002/3162 dated 18.11.2022 on the Appeal preferred by Thiru K.Vijendiran stating that,

***“the appeal made by Thiru Vijendirane for considering the issue of Nativity/Residence Certificate is found to be devoid of merit and hereby dismissed.”***

NOW THEREFORE, the undersigned hereby order that based on the order issued by the Deputy Collector (Revenue) North, Puducherry. Thiru K.Vijendiran, (Roll No. 2736 - MBC)), is not eligible for consideration of appointment to the post of Police Constable and his provisional selection stands cancelled.
