**GENERAL NOTICE**

Whereas, I, Dr. V.J. Chandran, IPS, Senior Superintendent of Police (L&O), Puducherry, having satisfied that there is likelihood of breach of peace in Puducherry District, owing to the proposed agitations/demonstrations by various political parties/organisations/associations, which may likely to cause dislocation to traffic, danger to the community and damages/loss to private and public properties and also disturbance to public order.

Now, therefore I, Dr. V.J. Chandran, IPS, Senior Superintendent of Police (L&O), Puducherry, in exercise of the powers conferred on me by virtue of Section 30(2) of the Police Act (Act V of 1861) do hereby impose the Regulatory Order, duly promulgated under Section 30(2) of the Police Act (Act V of 1861) in Puducherry District for a period of 30 days from 14-04-2016 to 13-05-2016 (both days inclusive) as follows:

**ORDER**

No person or class of persons shall convene or collect as an assembly or form or take out any procession or stage any demonstration/picketing on any road or street or thoroughfare or hold public meeting in Puducherry District for a period of 30 days from 14-04-2016 to 13-05-2016 (both days inclusive) except under and in accordance with the terms and conditions of license issued on this behalf by the Office of District Collector, Puducherry in respect of Puducherry Region and the Offices of Regional Administrators concerned in respect of Mahe & Yanam Regions and also do hereby require that every such person or class of persons as aforesaid intending to convene or take out procession or conduct such demonstration/picketing individually or collectively shall apply to the District Collector, Puducherry in respect of Puducherry Region and the Regional Administrators concerned in respect of Mahe & Yanam Regions for license atleast 48 hours in advance.

This Order shall not affect marriages, religious and funeral procession/ ceremonies and Govt. functions.
