In supersession of the Order cited, the Special Task Force (STF) trifurcated separately in North, South & Rural Sub-Division of Puducherry is amalgamated into a sole unit and will henceforth be called as "Special Task Force, Puducherry". Accordingly, orders are issued with necessary amendments in the above Order with immediate effect.

Strength & Supervision of the STF: The STF, Puducherry will be under the control of Inspector Thiru. S. Baskaran, assisted by SI S. Ramesh of Lawspet PS. The following strength of Police Personnel, working in various PSs/Units are attached with the STF, Puducherry:

SPs-North, South, Rural, Traffic and Wireless shall spare the above Police Personnel and direct them to report to Inspector (STF) immediately. The STF, Puducherry will be supervised by SSP(L&O).

- Jurisdiction: The jurisdiction of STF, Puducherry will be entire Puducherry Region.
  - Location of the Team : The STF, Puducherry will function in the first floor of Muthialpet PS.
  - Mobility: SP(MT) has already provided a light vehicle to the STF(North) Team for movement of the Incharge Officer. The Crime vehicle (Tempo Traveller Force), presently attached with STF(North) Team shall also be utilized for the movement of the Team.
- 5. Wireless Set, Telephone and Furniture, etc.: The static wireless set, telephone, computer and furniture, etc., already provided at the Office of STF(North) Team, shall be utilized by the STF, Puducherry.

## 6. Duties & responsibilities of the STF, Puducherry:

- (a) They shall search for information about heinous crimes, notorious criminals, hardcore rowdies, criminal gangs, their associates / leaders, follow-up some special clues and trace/track down the individuals wanted/concerned in cases.
- (b) They shall collect details, take action and also arrest the persons, who involves in the following crimes:
  - (i) Sale of lottery tickets DUDUS ATZ and rithin berostils
  - (ii) Gambling

(iii) Possession/sale/transportation of narcotic drugs & psychotropic substances

- (iv) Immoral trafficking
- (v) Fake and counterfeit currencies
- (vi) Extortion by Loading/Unloading Associations, Groups, etc.
- (c) They will have to control over the rowdy elements/bad characters/criminal gangs, residing in their jurisdiction including those persons indulging in land grabbing. Further, each and every activity of those lumpen elements shall be kept under surveillance of the STF.
- (d) The active local and non-local ex-convicts shall also be monitored by the STF in order to check their criminal activities.

- (e) They shall watch suspected persons and supply intelligence to the SPs concerned.
  - (f) They shall perform plain clothes patrols in sensitive areas and towns. The men in Plain clothes deputed shall observe bad characters/rowdies secretly.
  - (g) They shall take up the specific task of searching and apprehending accused persons.
  - (h) After the arrest of the accused person, they shall hand over him to the IOs concerned with a special report.
  - (i) They shall also keep a watch at the Bus stand, Railway Station, busy market places and liquor shops.
  - (j) The rowdies and criminals or their associates/relatives frequenting the Jail and Court, where secret watches shall be kept as the release and surrender of the accused are made in such places.
  - (k) Jail Release (Bad) elements often join hands with others to commit heinous crime. They shall also be shadowed.
  - (I) They shall maintain the details with photographs of the rowdy elements.
  - (m) Any other work assigned by the senior Police Officers.
  - (n) Clear and definite instructions will be given to the STF by the SSP(L&O). The movement of the members of the Team shall be supervised by the Inspector incharge, who shall issue Passports, wherever necessary with written instructions. The Inspector of the Team shall brief SSP(L&O) daily regarding their activities.
  - (o) Whenever the Inspector or SI of STF submits a special report, the same shall be embodied in the case diary to be written by the concerned IOs.
  - 7. The SDPOs in Puducherry Region shall utilize the services of STF in an effective manner. Whenever any heinous crime is reported, the STF Team shall also be informed henceforth, so that the members of the Team shall aware of the incident and act swiftly in apprehending the criminals.
  - All Units in Puducherry Police and Police Stations shall provide necessary assistance to the STF. The Special Branch shall also collect information about the involvement of criminals and inform the same to the STF.

9. All officers are hereby instructed to scrupulously follow the above instructions and utilize the services of the Special Task Force bearing in mind the principles of prevention of heinous crimes and notorious / hardcore criminals / land grabbers.
