

02. The deputation is subject to the following terms:-

- (i) the deputation will be for a period of three years in the first instance or till the service of the officer is required by the Hon'ble Welfare Minister or till the necessity for the post ceases, whichever is earlier;
- (ii) during the period of deputation, he will draw his basic pay plus deputation allowance at 10% subject to a maximum of Rs. 4000/- or pay in the scale of pay attached to the deputation post, as the case may be in accordance with and subject to the conditions laid down in O.M.No.2/29/91-Estt. (Pay.II) dated 05.01.1994 of Government of India, Ministry of Personnel, Public Grievance & Pensions (DoP & T), New Delhi. Communicated in G.O. Ms. No. 21, dated 25.03.1994 of DP&AR (PW), Puducherry; and
- (iii) during the period of deputation, he will continue to be governed by the rules applicable to him in his parent department.
