MINUTES OF THE BYE-ELECTION REVIEW MEETING,

HELD ON 01.11.2016

A meeting has been conducted by the undersigned on 01.11.2016 at 1200 hours to review the law & order arrangements with respect to the ensuing bye-elections to Puducherry Legislative Assembly from Nellithope Constituency. The SDPOs, Circle Inspectors and SHOs in Puducherry attended the meeting. SP(Election Cell), DC/AC of IRBn. and Inspector/STF were also present. During the meeting, the following instructions were given :

- Labels*
- The 'Model Code of Conduct' shall be strictly enforced.
  - There is a rumour that some anti-social elements from the neighbouring districts of Tamilnadu are roaming in Puducherry to mar the bye-election process. This should be contained immediately with an iron hand.
  - All the Guest Houses and possible places of stay shall be checked by the Beat Officers regularly, for people from neighbouring districts of Tamilnadu staying overnight in Puducherry. The Managers of the Guest Houses shall be insisted to maintain the records properly with ID proof of the guests staying in the rooms.
  - The Externment proposals under the provisions of Sec. 144 Cr.P.C., pending with the District Magistrate, shall be submitted by the SDPOs to the undersigned immediately for proceeding further in the matter.
  - The Two-Wheeler Hiring Shops and Cabs shall be insisted to maintain proper records with ID proof of their customers/passengers.
  - The Licensed Arms holders shall be advised to deposit the Arms immediately in the respective Police Stations and proper entries shall be made in the Gun Licence Register for receipt and the Arms shall be returned once the 'Model Code of Conduct' ceases.
  - Special attention shall be paid in executing the pending warrants.

- h. Border Check-Posts shall be adequately covered. Movement of cash, gift items and other banned articles shall be watched carefully.
- i. The liquor shops and arrack shops shall be checked regularly. It shall be ensured that no sale of liquor items is carried out without any bill. The stock may also be checked in liaison with the excise department officials.
- j. Transportation of liquor to other States shall be checked and prosecuted.
- k. Visible group patrolling shall be undertaken in the evening hours to instill confidence among the members of general public.
- l. Inspector/STF was instructed to check the bad characters on day-to-day basis.
- m. DC/AC, IRBn. were instructed to spare one platoon of IRBn. to SHO/Orleanpet PS, round-the-clock for law & order bandobust duty till the bye-election process is over.
- n. It shall be ensured that the Bye-Elections are conducted in a free, fair and peaceful manner.
