Sub: Prevention of organized Crime, revenge killings, etc. - Regarding.

Dated: 30/05/2018

During the review of heinous crimes occurring in the U.T. of Puducherry, it has been found that in many cases the persons released from jail in heinous crime have indulged in revenge killings. Moreover, the petty criminals also become active soon after the release from jail. In view of this, the following guidelines should be followed by all concerned to control and prevent such types of crimes.

I. MAINTENANCE OF DATA OF POTENTIAL CRIMINALS:

Maintenance of records of the criminals, if necessary, to keep a watch over their activities. SDPOs / CIs / SHOs should liaise with the jail authorities to get the details of released criminals and the same should be briefed to the beat officers who will keep regular watch over their activities. The help of social media can be taken for immediate response; however it should be followed by the written communication.

CIs / SHOs should also contact the jail authority and get the history of any dispute among two rival groups in the jail. It has been reported that even small dispute in jail has subsequently led to the revenge killing after the release of such groups. Prior knowledge of petty disputes inside the jail will help in preventing revenge killing.

- (c) A special vigil has to be maintained over the activities of the murder accused who have been released on bail. The bail should be got cancelled depending upon their activities in order to avoid the possibility of revenge murder.
- (d) The annual booklet should be made regarding potential revenge killers which will include all the above category of criminals. The booklet should be distributed to all concerned police stations.



(e) Similarly, the booklet also be prepared for the released burglars / motor vehicle thieves / snatchers so that adequate prevention of crime can be made.

II. SURETY REGISTER:

- (a) The details of persons who stood surety to the accused persons for their enlarging on bail should be collected and scrutinized. In case it is found to be false, the bail should be got cancelled. The surety register must be maintained in each police station and be updated.
- (b) Similarly, the profile of the relatives / supporters / friends of the victim should also be prepared and their psychological conditions should be examined through various sources as they may also indulge in revenge killing.

III. MONITORING OF THE BAIL MATTERS:

- (a) The CIs & SHOs shall closely monitor the bail applications, filed by the accused persons, especially in heinous crimes. The bail objections should be prepared properly and it should be filed well in advance through the Public Prosecutor concerned after getting vetted by the SDPOs.
- (b) The learned Judges should be requested that the place of daily appearance of the accused persons, specified in the bail conditions should be atleast in outlying regions of Puducherry, so that their movements in affected area could be curtailed.
- (c) The CIs & SHOs should immediately file for the bail cancellation if any one of the condition put by the court is violated by the accused persons.

IV. USE OF VIDEO CONFERENCING FACILITY:

Sincere efforts be made to ensure that the remand / bail matters of the accused and evidence of trial prisoners are decided / recorded through video conferencing.

V. MEETING WITH THE PROSECUTION AGENCY:

Regular meetings shall be conducted by the Director of Prosecution involving the Officers of Police, Prison & Prosecution.

VI. REFORMATION PRACTICES IN THE PRISON:

The Inspector General of Prisons has already been requested to initiate the reformative practices and counselling of the jail inmates inside the Prison.

VII. NODAL OFFICER:

The Director (Crime Records Bureau) will be the Nodal Officer for this purpose. He shall collate the data, received from all the Police Stations and circulate to all the SHOs. He shall be assisted by Inspector (STF).
