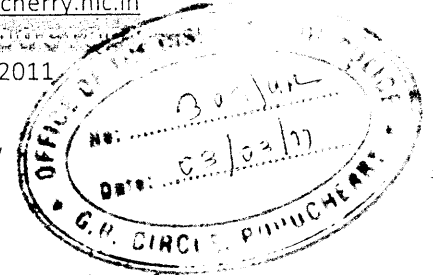

Sub.: Elections-Conduct of General Election to the Puducherry
 Legislative Assembly 2011 – Model Code of Conduct –
 Constitution of Standing Committee - Order-Issued.

The Election Commission of India will be announcing the schedule for the conduct of the General Election to the Puducherry Legislative Assembly 2011 very shortly. With the announcement of the Election, the Model Code of Conduct will come into force. In order to ensure total compliance with the Model Code of Conduct and also for considering specific violations of the Code, District wise and Constituency-wise Standing Committees comprising of the following members shall be constituted with immediate effect:

Composition of Standing Committee for Puducherry District

District Election Officer, Puducherry	Chairman/Convener
Senior Superintendent of Police (L&O)	Member
One Representative from each of the recognized National/State Parties	Member

Composition of Standing Committee for Karaikal District

District Election Officer, Karaikal	Chairman/Convener
Senior Superintendent of Police	Member
One Representative from each of the recognized National/State Parties	Member

Composition of Standing Committee for Assembly Constituencies

Returning Officer of the Assembly Constituency concerned	Chairman
Circle Inspector of Police of the Assembly Constituency concerned	Member
Contesting Candidate	Member
AROs of the Assembly Constituency concerned	Convener

- The Committees shall meet as often as necessary and shall take all necessary steps during the election period for preventing and checking any instance of election offences. Minutes of the meetings shall be sent to Chief Electoral Officer, Puducherry then and there.
- The first meeting of the Committee shall be convened by the District Election Officers / Returning Officers immediately upon announcement of election to impress upon the Political Parties the provisions of the Model Code of Conduct.
- The Committees can also discuss regarding sorting out any problem relating to conduct of elections.
