INFORMATIONS AND CONDITIONS:

- 1) The subject matter shall be super scribed on the cover as "**Quotation for supply of "LED Bar light and PA system"**".
- 2) The Quotation paper should be put in a sealed cover addressed to Superintendent of Police(HQ), No.2, Dumas Street, Puducherry. The quotation should reach this office or it may be dropped into the Quotation Box placed at the Offices of SP (HQ) of this Department before the due date mentioned below and intimate your acceptance on the following conditions in case rate(s) quoted by your firm are accepted and supply order is placed with you.
- 3) The bidders should quote rate per unit only for the specification mentioned in the quotation notice.
- 4) Price should be quoted for one item and all pages should be signed by the bidder. The quotation without price for any one of the items will be summarily rejected.
- 5) The firms are requested to provide rates including all charges for the above items. VAT / CST may be charged extra.
- 6) The item should be reputed Branded make.
- 7) No insurance charges is payable. The purchaser will not pay separately for a transit insurance and the supplier should be responsible until the items arrive in good condition at the destination and for this purpose the rates quoted should be inclusive of insurance charges.

- 8) The rates to be furnished by the firms should be valid at least for 6 months from the due date and any upward revision of Tax, Cess, etc., would have no impact on that rate(s), while any downward revision should / will duly get effected during the said period.
- 9) The item should be supplied strictly in accordance with the specifications given in the requirement. The items, which do not conform to the specifications quoted in the quotation will be returned to the supplier at their cost.
- 10) F.O.R. Puducherry Freight paid at owner's risk. The item should be handed over in person by the successful bidder to the SP(HQ).
- 11) The Police Department, Puducherry is not responsible for the delay in transit if the quotations are sent by post. The bids received late, i.e., after the date & time prescribed, shall not be accepted. In case of unforeseen circumstances the date of opening of bid will be next working day or as notified separately.
- 12) Last Date and Time of receipt of quotations is ~~02~~ 07.2019 upto 16 00 hours. The quotations will be opened on the same day at 17 00 hrs.
- 13) The items have to be supplied within 15 days on receipt of supply order as door delivery and the charges for the purpose to be borne by the supplier.
- 14) Mention your TIN, PGST Nos. and Telephone/Mobile Numbers, etc., in your quotation clearly.
- 15). The quantity mentioned above may decrease or increase while the supply order is placed.
