

The quotation will be opened on the same day at 17.00 hours by the Purchase Committee on the same day in the office of the SP(HQ) in the presence of bidders or their authorized representatives. In case of unforeseen circumstances the date of opening will be a holiday, the day of opening will be next working day.

5. The bidders should furnish the copy of the TIN Number Registration along with their quotations without fail. Rates should be quoted F.O.R. Puducherry and delivery should be given in the premises of this Department's Chief Stores, Gorimedu, Puducherry-6. The bidders may quote the rate either for one or all the 21 items mentioned as above. **The validity of rates should be for one month from the date of opening of bids.** The rates once quoted and approved will be final until the supplies are received and accepted and no deviation in rates will be allowed thereafter due to market fluctuations or any other reasons.
