**MINUTES OF THE MEETING WITH THE NODAL OFFICERS OF
'TELEPHONE SERVICE PROVIDERS', HELD ON 02.02.2018**

A meeting with the Nodal Officers of 'Telephone Service Providers' was convened by the undersigned on 02.02.2018 at 1230 hours at the Office. The officials from TSPs took part in the meeting alongwith the SDPOs, CIs & SHOs in Puducherry and Inspector/STF. The following decisions were taken during the meeting:-

1. At the outset, the TSPs were appreciated for rendering their co-operation during the last year in delivering their services in a timely manner. As a token of recognition, Appreciation Letters were given to them. They were requested to continue the same in the coming years also.
2. The TSPs were requested to provide the CDRs & other details to the authorised Police Officers mentioned herein within a maximum time limit of 24 hours, if request is sent from their official email IDs.
3. The TSPs were also requested to provide the details of SDR and Tower Locations to all CIs / SHOs within the shortest possible time via SMS to assist them and Crime Team on the field, if request is sent from their Official CUG Mobile Phones (which starts from No. 94892-05...). Tower Location shall be provided with address and Tower ID. This will help mitigate the hardship faced by field officers in decoding it.
4. Details of their official email IDs and CUG numbers are available in the Police Website "police.puducherry.gov.in". Web Officer shall liaise with TSPs if any doubt arises with reference to above.
5. In case of any delay, the Police Officers concerned shall liaise with the respective Nodal Officers to expedite the same.
6. As per the decision taken in the last meeting, the practice of sending scanned copy of the lawful interception order to the TSPs through e-mail would continue. Later, the hard-copy will be handed over in person to the Nodal Officer.
7. The mobile phones in respect of Jio, especially 4G and BSNL are found to be reachable within the precincts of Central Jail, Kalapet though Mobile Phone Jammer is functional. The Nodal Officers of both the TSPs were requested to carry out the walk-survey immediately after approaching the Jail authorities.
8. The TSPs were requested to provide the details of SIM holders if name & address of persons are furnished.
9. The sale of pre-activated SIM cards should be stopped and only after proper verification of documents, the SIM cards should be activated.

10. The TSPs were requested to continue to share the subscriber details on DVD to the Office of the undersigned, representing Puducherry Police. The Web Officer shall be the custodian of subscriber data base and also maintain it and retrieve it as and when needed.
11. The TSPs were requested to communicate with the officers concerned even during odd hours including Sundays and Public Holidays for the purpose of Tower Locations, Subscribers details and CDRs in view of sensitivity of the cases.
