4. The Police Department, Puducherry is not responsible for the delay in transit if the quotations are sent by post. The bids received late, i.e., after the date & time prescribed, shall not be accepted. In case of unforeseen circumstances the date of opening of bid will be next working day or as notified separately.
5. **Last Date and Time of receipt of quotations is 01.02.2019 upto 16 00 hours. The quotations will be opened on the same day at 17.00 hrs.**
6. The quotation should be addressed to SP(HQ), Puducherry and the subject matter shall be superscribed as "**Quotation for Repair of 12 Ton Interceptor Boat**" on the cover.
7. The items have to be supplied within 7 days on receipt of supply order as door delivery and the charges for the purpose to be borne by the supplier.
8. The materials which do not conform to the specification will not be accepted.
9. The rates to be furnished by the firms should be valid at least for 6 months from the due date and any upward revision of GST, Cess, etc., would have no impact on that rate(s), while any downward revision should / will duly get effected during the said period.
10. Mention your TIN, PGST Nos. and Telephone/Mobile Numbers, etc., in your quotation clearly.
