The firm is requested to provide the estimate/supply rate including terms and conditions additional charges like GST etc., for the above items in a 'sealed cover', the subject matter shall be superscribed as "Quotation for supply of RG 213 co-axial cable and LMR 400 co-axial cable various spares for wireless static/mobile and walkie-talkie sets" on the cover and addressed to the Superintendent of Police (HQ), No.2, Durais Street, Puducherry – 605 001.

The quotation should reach this office or it may be dropped into the Quotation Box placed at the Office of the Superintendent of Police (HQ) of this Department before the due date mentioned below and intimate your acceptance on the following conditions in case rate(s) quoted by your firm are accepted and supply order is placed with you.

The samples should also simultaneously reach the Office of the Superintendent of Police (Headquarters), Puducherry. sample received after the due date and time will not be considered under any circumstance. *The sample may sent by registered post or handed over to Receipt Section of the Superintendent of Police (HQ) under acknowledgement on or before 16.00 hrs on 11.01.2021.*

5. The Police Department, Puducherry is not responsible for the delay in transit if the quotations are sent by post. The bids received late, i.e., after the date & time prescribed, shall not be accepted. In case of unforeseen circumstances the date of opening of bid will be next working day or as notified separately.
6. **Last date and time of receipt of quotations is 11.01.2021 at 16.00 hours. The quotations will be opened on the same day at 17.00 hours.**
7. The items have to be supplied within 15 days on receipt of supply order as door delivery and the charges for the purpose to be borne by the supplier.
8. The materials which do not conform to the specification will not be accepted.
9. The rates to be furnished by the firms should be valid at least for 12 months from the due date and any upward revision of GST, Cess, etc., would have no impact on that rate(s), while any downward revision should / will duly get effected during the said period.
10. Mention your TIN, GST Nos. and Telephone/Mobile Numbers, etc., in your quotation clearly.
11. No advance payment should be insisted in the quotations.
