
Sub: Esst.I(B) – Issue of Tentative seniority list to the Police Constables appointed by Court directions – Circulated - Reg.

Ref: This Department's Memorandum of even number dated 13.04.2009.

Final seniority of Police Constables, who were appointed in the year 2007, upto the seniority No. 2923 issued vide the reference cited. 13 candidates who have been selected for the post of Police Constable in the year 2007 under direct recruitment were not considered for appointment due to non-availability of vacancy at that time. However, as per court directions they were appointed as Police Constable during the year 2008 and 2010. In order to issue final seniority list to them, a tentative seniority list from seniority No.2924 to 2936 in respect of 13 Police Constables who were appointed by Court directions is prepared as per rules and circulated.

Objections, if any, to the tentative seniority list as per the Annexure assigned to them, the individuals concerned may submit their representations along with relevant documents in support of their claims to the undersigned on or before 23.02.2022. If no objection is received within the stipulated time it will be presumed that they have no objections on their seniority and the seniority will be finalized.
