02. The deputation is subject to the following terms:-

- the deputation will be for a period of five years in the first instance or till the service of the officer is required by the Hon'ble Chief Minister/Minister for or till the necessity for the post ceases, whichever is earlier;
- during the period of deputation, he will draw his basic pay plus deputation allowance at 5% subject to a maximum of ₹ 2,000/- or pay in the scale of pay attached to the deputation post, as the case may be in accordance with and subject to the conditions laid down in O.M.No.2/29/91-Estt. (Pay.II) dated 05.01.1994 of Government of India, Ministry of Personnel, Public Grievance & Pensions (DoP&T), New Delhi communicated in G.O.Ms.No.21, dated 25.03.1994 of DP&AR(PW), Puducherry; and
- during the period of deputation, he will continue to be governed by the rules applicable to him in his parent department.
