**NOTIFICATION**

WHEREAS, in Puducherry Region, Traffic Police Station, Puducherry and Traffic Police Station, Villianur are functioning at Jawaharlal Nehru Street, Puducherry and at No.4, Navasannathi Street, Villianur, Puducherry, respectively under the supervision and control of the Superintendent of Police(Traffic), Puducherry with the extent of jurisdiction as specified in G.O.Ms.No.8 dated 03.02.2005 of Home Department, Government of Puducherry;

AND WHEREAS, it has been decided to trifurcate the entire Traffic Unit, Puducherry Region as Traffic Police Station(North), Traffic Police Station(South) and Traffic Police Station (Rural) for effective control and management of Traffic in the Puducherry Region;

NOW THEREFORE, in pursuance of clause(s) section 2 of the Code of Criminal Procedure, 1973(Central Act 2 of 1974), the Lieutenant-Governor, Puducherry is pleased to declare that the Traffic Unit(North), Traffic Unit(South) and Traffic Unit (Rural) at Puducherry Region shall be the Traffic police Stations and is also pleased to specify, in partial modification of the notification issued in No.63-41/67-Home, dated 26<sup>th</sup> September, 1967 of the Chief Secretariat(Home Department), Puducherry the extent of jurisdiction of the Traffic Police Stations at Puducherry Region as detailed below:-
