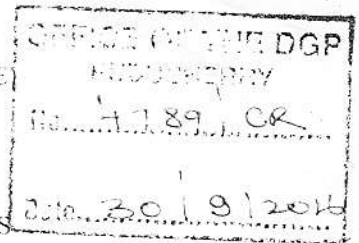

CCTNS IMPLEMENTATION ALREADY IN PROGRESS AND THE SCHEME ENDING IN MARCH 2017 [.] WITH RESPECT TO UPLOADING FIRST INFORMATION REPORT (FIR) ONLINE HON'BLE SUPREME COURT JUDGMENT IN WP (CRL) NO. 68/2016 INTER-ALIA REQUIRES THAT "FIR SHOULD BE UPLOADED ON THE POLICE WEBSITE AND IF THERE IS NO SUCH WEBSITE, ON THE OFFICIAL WEBSITE OF STATE GOVERNMENT, WITHIN TWENTY FOUR HOURS OF THE REGISTRATION OF THE FIRST INFORMATION REPORT [.] PROVISION EXISTS IN CCTNS TO GENERATE THE FIR WHICH CAN BE UPLOADED BY THE STATES/UTs ON THEIR POLICE WEBSITES [.] THE LINK TO SEARCH UPLOADED FIR CAN BE GIVEN ON THE CITIZEN PORTAL [.] EXPENDITURE RELEASED FOR CCTNS CAN ALSO BE UTILISED TO LAUNCH THE CITIZEN PORTAL WHEREVER NOT LAUNCHED ACTION CAN BE DONE ON PRIORITY [.] ALREADY 15 STATES HAVE LAUNCHED CITIZEN PORTAL AND WORK IS IN PROGRESS IN OTHER STATES/UTs UTILISING 100% FUND UNDER CCTNS RELEASED BY JS (PM) MHA [.] ANY TECHNICAL CLARIFICATION CAN BE HAD ON NO. 011-26169722 [.]
