CIRCULAR

Sub: Observation of Vigilance Awareness week 2021 - Reg.

The Commission has desired to spread awareness and campaign about "Complaints under PIDPI (Public Interest Disclosure and Protection of Informers)" and to display the information posters in all offices. In this regard, two posters forwarded by the Commission are attached herewith for displaying it in all the Offices of the Departments/ Organisation.
