Constitution of Taluk level L&O teams –Reg.

As per the directions of the District Magistrate, the Sub Divisional Magistrates shall constitute teams for maintaining constant vigil to ensure that the weeklong celebrations of Vinayaka Chaturthi and immersion of the idols passes off peacefully. The team shall be constituted at the level of Station House Officer and the team shall comprise of the following members as stated below;


- (i) Deputy Tahsildar-cum-Executive Magistrate
- (ii) Station House Officer
- (iii) Village Administrative Officer of the concerned Revenue Village
- (iv) Local representatives of the festival committee


2. The Station House Officers shall:

- (i) Provide to the SDM and the EM a list of the locations permitted for setting up of idols of Lord Ganesh, details of the organizers, contact details of the persons / representatives of the organization committee responsible for the location, and any other relevant details to the Sub Divisional Magistrate and the Executive Magistrate.
- (ii) Deploy additional beat for these locations.
- (iii) Accompany the concerned Executive Magistrate(s) during his visit to these locations.
- (iv) Conduct meeting with the local leader of the celebration committee and pass appropriate instructions for maintaining Law and Order.
- (v) Brief about the procession plan of the immersion of the idols.
- (vi) Debrief on completion of the immersion procession.
