Sub: Police – Estt I – Selection to the post of Radio Operator/
RTPC/MPC/WHPC by Transfer Method - Orders issued– Reg.

On the basis of the recommendations made by the Police Establishment Board, the individuals mentioned in the annexure are *selected by transfer method and appointed as Radio Operator, Radio Telephony Police Constable, Messenger Police Constable and Workshop Hand Police Constable* mentioned against each names of the individual in the existing/resultant vacancies *on purely ad-hoc basis, with immediate effect* in the scale of pay of Rs. 5,200 – 20,200 ± GP Rs.2,000 plus usual allowances.

2. They will continue to draw their present pay and allowances in the same scale of pay or in the higher scale of pay granted under ACP/MACP Scheme, as admissible under rules in force from time to time.
3. The selected candidates those who have not completed the basic wireless training are subject to undergo Police Wireless Operator Grade III Course conducted / approved by the DCPW.
4. Further, they are directed to report before the Superintendent of Police (Wireless), Puducherry /SP Karaikal/Mahe and CI Yanam and submit their joining report.
