NOTIFICATION

The Ministry of Women and Child Development, Government of India has introduced the "Swadhar Greh Scheme"(hereinafter referred as to Scheme") w.e.f. 01.01.2016 by merging the earlier two Schemes viz., "Swadhar" and 'Short Stay Home' and the new scheme targets the women victims of unfortunate circumstances who are in need of institutional support for rehabilitation so that they could lead their life with dignity.

In pursuant to the sub-clauses(i) and (ii) of clause O of the Scheme and for the effective implementation, monitoring and supervision of the Scheme, the Hon'ble Lieutenant Governor, Puducherry is hereby pleased to constitute the State Level Monitoring Committee and District Level Monitoring Committee, consisting of:



3. The District Level Monitoring Committee shall meet at-least once in a quarter. The Deputy Director, Women Development wing of Department of Women and Child Development shall be responsible for Co-ordinating all the activities related to implementation of the scheme.

4. The Social Audit on the Scheme "Swadhar Greh" shall be carried out by the external agencies as prescribed by the Government of Puducherry.
