The main object and responsibility of the above cell is as under :

- i. To Investigate cases relating to Human Trafficking.
- ii. To Identify the gangs/organizations involved in Human Trafficking- both land and sea based routes.
- iii. Persons responsible and assisting Human Trafficking.
- iv. To Identify and investigate especially women/child Trafficking incidents.
- v. Thorough interrogation of suspects / anti social elements indulging in Human Trafficking.
- vi. To enquire and investigate aspects of smuggling etc related to human trafficking.
