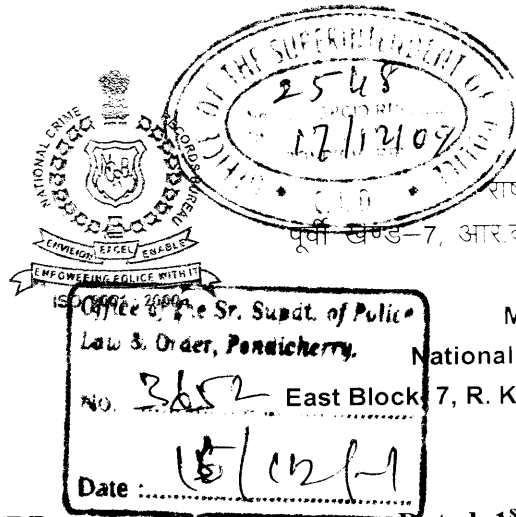

Dear Ms. Pillai,

You may recall the request of several nodal officers of States/UTs who attended successive nodal officers meetings in NCRB chaired by me and MHA officials that the NCRB/ MHA may prepare an empanelled list of potential State Project Management Consultants (SPMCs) for CCTNS implementation in States/UTs. In pursuance of this demand of the States/UTs we have approached Department of Information Technology, Government of India to send us a list of consultants dealing with various e-Governance projects at the State/UT level. They have submitted a list of such qualified consultants (list enclosed). They have been evaluated by DIT on their capabilities for performing as consultants on e-Governance projects of Government of India. In this regard States/ UTs have the following options to select their SPMC:

1. You may choose one of these consultants from the list enclosed or
2. Engage additional resources from the State SeMT that has been established in your State through a national level tendering process conducted by DIT, GoI as well as the State Government or
3. You may go for a firm outside this list by following appropriate open tendering formalities.

Also the Model Terms of Reference for SPMC selection is enclosed along with this letter for further necessary action at your end.
