MINUTES OF THE POLICE-PUBLIC INTERFACE MEETING HELD AT POLICE
COMMUNITY HALL, GORIMEDU ON 14.09.2012 AT 1100 HRS.

A "Police - Public Interface Meeting" was conducted in Puducherry on 14.09.2012 at 11.00 hours at Police Community Hall, Gorimedu, Puducherry. Around 100 general public of Puducherry participated in the meeting. IGP chaired the meeting. DIGP(Admn), SSP(L&O), SSP(Traffic), SP(South) and SP(Rural) were attended the meeting.

Traffic Issues:

1. "Free Left" arrangement be made to avoid traffic congestion during peak hours.
2. School Buses are to be inspected and regulated as per law.
3. Overloading of school buses be controlled by checking such buses.
4. Regular co-ordination meetings between Police and Transport Departments be conducted.
5. Parking of vehicles at J.N. Street should be changed from right side to left side to avoid accidents.

Law and Order Issues:

1. Stern action should be taken against the cases of Crime Against Women.
2. 75% of the top criminals of Puducherry are from North and South Sub-Divisions only. Therefore, police may concentrate more on the areas to curb the activities of criminals to a large extent.
3. The cut-outs and banners should be removed then and there without any delay.
4. Opportunities should be given to criminals to live as good citizens of the society and false preventive cases should not be registered on them.

Prison Issues:

1. Powerful jammers be installed at Puducherry Central Prison at Kalapet to control the operation of criminals through mobile phones.

Issues relating to Development Proposals:

1. Police Control Room Vans are very less number and it should be increased.
2. CCTV cameras should be fitted in important junctions / places.

General Issues:

1. Criminals are making use of children below 18 years which is a very serious issue. Necessary counseling should be done at school levels and village level.
2. The secrecy of the information received by Police should be maintained and the identity of the informer should never be revealed.
3. One week advance notice may be given before organizing "Police-Public Interface Meeting".

At the conclusion of the meeting, IGP has answered for all the above issues and instructed the concerned SSPs / SPs to pay attention on the issues raised by the participants and take action accordingly and compliance be submitted.

KARAIKAL DISTRICT

MINUTES OF THE POLICE-PUBLIC INTERFACE MEETING HELD AT MUNICIPAL MARRIAGE HALL, KARAIKAL, ON 15.09.2012 AT 1030 HRS.

Similarly, a 'Police - Public Interface Meeting' was conducted in Karaikal District on 15/09/2012 at 10:30 hours at Municipal Marriage Hall, Bharathiar Road, Karaikal. Around 180 - 200 general public of Karaikal including school students and ladies participated in the meeting. The following points were raised by the general public in the meeting.

With regard to Development Proposals - issues raised were

- 1) CC TV installation at important junctions
- 2) Separate Vigilance Unit and other units to be established in Karaikal.

Requests with regard to Other Departments

- 1) Spot permit be arranged for tourist vehicles
- 2) Posters over the street name boards at Thirunallar - atleast tax shall be collected.
- 3) Stray dogs and pigs menace
- 4) Kerala fish vans spilling water over Nagore main road - Foul smell - harmful to health

With regard to Traffic - issues raised were

- 1) Railway land in the old railway line to be utilized as parking place.
- 2) Black stickers in head lights
- 3) Spot fine system to be implemented.
- 4) Traffic personnel should be posted regularly at important junctions of Thirunallar.
- 5) Stray Cattle menace to be curbed.
- 6) Posting of men before Thanthai Periyar Govt. Higher Secondary School, Karaikal during peak hours
- 7) Share autos parking haphazardously
- 8) Sufficient timing to be given for pedestrians to cross in the Traffic Signals.
- 9) Overcrowding in PK Salai

With regard to instructions to be given to Police - Issues raised were

- 1) Acknowledgement slips for complaints.
- 2) The persons who assist the accident-met persons or any other person in danger and taking to GH should not to be harassed.
- 3) Arrack shop along road side at Kakkamozhi, Neravy causing nuisance to the by-passers especially the school going girls and ladies.
- 4) Functioning Mela Vanjore check post round the clock.
