ORDER:

Sanction is accorded to the creation of 30 posts in Police Department, Pondicherry under F.R.127 as detailed below for posting of security personal at Oil & Natural Gas Commission complexes in Karaikal region for a period commencing from the date of entertainment till 28.2.'94 or till the necessity therefor ceases whichever is earlier:-

1. Head Constable - 6 posts
(Rs.975-25-1150-EB-30-1660)
2. Police Constable -24 posts
(Rs.825-15-900-EB-20-1200)

2. Sanction is also accorded to the deputation of the incumbents of the above posts to ONGC Complexes in Karaikal region with immediate effect. During the period of deputation, the personnel will draw their grade pay applicable to them plus usual allowances at the rates in force from time to time. The posts shall automatically stand abolished when the staff are no longer required by ONGC, Karaikal.

3. The deputation is subject to the condition that the leave salary and pensionary contributions should be recovered from the above Institution on the scale which will be fixed by the Director of Accounts and Treasuries, Pondicherry and communicated to the above Institution separately. The payment of T.A. and D.A. and transfer T.A. if admissible shall be regulated in accordance with the provisions contained in the F.Rs. and S.Rs. and the expenditure should be borne by the above Institution.

4. During the period of deputation, they will be entitled to the benefits of medical attendance rules as per the rules in force under this administration and the expenditure should be borne by the above Institution. The expenditure on supply of uniforms, on account of usage of arms and ammunitions etc.

will be recovered from the above Institution. The above Institution should also bear the whole expenditure in respect of any compensatory allowances for the period of leave in or at the end of foreign service and also pay the leave salary charges in respect of any disability incurred in and through foreign service even though such disability manifests itself after the termination of foreign service. No additional pensionary contribution shall be recovered in respect of the period of disability.

5. The above personnel will remain subject to leave rules applicable to the service of which he is a member. Penal interest will be levied under S.R.-307 if payment of leave salary or pension is delayed. Pension and leave salary contributions shall be credited under the relevant receipt head in the budget.

6. The above institution should deposit at the nearest treasury an amount equal to three times the pay and allowances of ** and refunded to them after the expiry of the period of employment of the officials and after the claims of the Department and the officials have been settled.

7. The pay and allowances of the personnel accommodated against the posts created in para (1) above shall be debited to the relevant head in the budget of police Department.
