NOTIFICATION

In exercise of the powers conferred by clause(s) of
section 2 of the Code of Criminal Procedure, 1973 (Central
Act 2 of 1974), the Lieutenant Governor, Pondicherry hereby
declares the Police Out Posts set up at Lawspet, Mettupalayam,
Krumampakkam and Katterikuppam as Police Stations with
immediate effect and hereby makes the following amendment
to the notification issued in Home Department's G.O.Ms.No.
48, dated 28th July, 1987, namely:-

AMENDMENT

In the schedule annexed to the said notification, —

1. in the entries against serial number 5-

- (a) under column (3) for the words "Mettupalayam
Outpost" the words "Mettupalayam Police Station"
shall be substituted and
- (b) under column (4) for the words "newly formed
Outpost Mettupalayam", the word "Mettupalayam"
shall be substituted.

2. in the entries against serial number 6 -

- (a) under column (3) for the words "Lawspet
Outpost", the words "Lawspet Police Station"
shall be substituted; and
- (b) under column (5), the words "Government
Servant Quarters, Lawspet, Rajaji Nagar,
Tagore Nagar, Avvai Nagar" shall be omitted;

3. after serial number 6 and the entries relating
thereto, the following shall be inserted, namely:-

 - (a) under column(5), the words, "Thuthipet, Karasur Sedarapet" shall be deleted;
- (6) after serial number 15 and entries relating thereto, the following shall be inserted, namely.
