O R D E R:

In supersession of the order issued in G.O.Ms.No.26,
dated 27th February, 1981 of the Home department, Government
of Pondicherry, except as respects things done or omitted
to be done before such supersession, the Lieutenant Governor,
Pondicherry is pleased to notify that law and order division
in the Pondicherry region of the Union Territory of Pondicherry
shall be placed under the control of the Superintendent of
Police(North) and the Superintendent of Police (South) with
the following Police Stations and Police Outposts within
their jurisdiction, namely:-

I. Superintendent of Police (North):-

- (a) Grand Bazaar Circle consisting of,-
 - (i) Police Station, Grand Bazaar; and
 - (ii) Police Station, Odiamsalai.
- (b) Muthialpet Circle consisting of,-
 - (i) Police station, Muthialpet;
 - (ii) Police Outpost, Solai Nagar;
 - (iii) Police station, Lawspet;
 - (iv) Police Outpost, Lawspet Govt. Quarters; and
 - (v) Police Station, Kalapet.
- (c) Dhanvathi Nagar Circle consisting of,-
 - (i) Police Station, D'Nagar.
 - (ii) Police station, Orleanpet; and
 - (iii) Police Station, Mettupalayam.

II. Superintendent of Police (South):-

- (a) Mudaliarpuram Circle consisting of;-
 - (i) Police Station, Mudaliarpuram;
 - (ii) Police station, Ariankuppam; and
 - (iii) Police station, Thavalakuppam.
- (b) Villianur Circle consisting of,-
 - (i) Police station, Villianur;
 - (ii) Police Outpost, Mangalam;
 - (iii) Police Outpost, Korkadu; and
 - (iv) Police Station, Reddiarpalayam.

(c) Bahour Circle consisting of,-

- (i) Police Station, Bahour;
- (ii) Police Outpost, Karaiyambuthur;
- (iii) Police Station, Nettapakkam;
- (iv) Police Outpost, Maducarai; and
- (v) Police Station, Kirumambakkam.

(d) Thirukanur Circle consisting of;-

- (i) Police Station, Thirukanur;
- (ii) Police Station, Thirubuvanai;
- (iii) Police Station, Katterikuppam; and
- (iv) Police outpost Sedarapet.
